

## **London Landmarks Half Marathon 2025 – General Terms and Conditions of Participation**

Firstly, thank you for your interest in supporting The Children's Trust by joining our London Landmarks Half Marathon Squad. The London Landmarks Half Marathon is a popular and important fundraising event for The Children's Trust.

The following terms and conditions have been written to support you and to set out the expectations of the charity and our commitment to you should you be awarded a place.


If you are successful in gaining a place with The Children's Trust:


## Registration

- You will pay a £25 registration fee within 10 days of being offered a place with The Children's
  Trust. If the registration fee is not paid by day 11, The Children's Trust reserves the right to
  release your place to the next potential runner, unless agreed otherwise and in writing.
- You acknowledge that the registration fee is non-refundable, non-transferable and cannot be used to towards your fundraising target.
- You agree to the terms and conditions set out by London Landmarks Half Marathon Events.
- You will register your name and personal details with London Landmarks Half Marathon Events separately. Details of how to do this and the deadline for doing so will be communicated with you by The Children's Trust. You will be unable to take part without completing this registration by the deadline. The deadline is governed by London Landmarks Half Marathon Events and no extensions are awarded under any circumstances.

# **Fundraising**

- You agree to raise at least the minimum sponsorship requirement (£350) and will send all sponsorship funds no later than six weeks after the event. Gift Aid donations do not count towards the minimum sponsorship requirement. In the event you do not raise the minimum sponsorship requirement (£350) by six weeks after the event, you accept and acknowledge that you must pay the shortfall from your own funds to The Children's Trust no later than seven weeks after the event. This is to ensure that The Children's Trust is not in a financial deficit due to the cost of your place.
- You will commit to raising 100% of the minimum sponsorship by 21<sup>st</sup> April 2025.
- You understand that The Children's Trust has the right to withdraw your place at any time with due warning if they consider that you are not committed to your pledged sponsorship.
- If you fail to raise the £350 fundraising pledge with no prior arrangement or exception, The Children's Trust can inform London Landmarks Half Marathon Events (the organiser) and it may impact your chances of running in future London Landmarks Half Marathon Events.









- If you do not take part in the event, any sponsorship money raised will be treated as donations unless your sponsors contact The Children's Trust directly for a refund.
- For any independent fundraising events that you carry out to raise funds (for example a cake sale or pub quiz), you acknowledge that you are carrying such events out in your own capacity. It is your responsibility to organise all aspects of such event and make it clear that such event is run by you "in aid of" The Children's Trust and is not run by the charity. The Children's Trust will not accept any responsibility or liability for such event. If you wish to use The Children's Trust logo, please contact the Events team who can provide an "in aid of" logo.
- You agree to raise all money using legal methods and complying with the advice given in the in the How to Fundraise section of our website.

## General

- You will be at least 17 years old on race day (6<sup>th</sup> April 2025).
- You are taking part in this event at your own risk.
- You confirm that, as far as you are aware, you are fit and healthy enough to take part in this
  event.
- You will notify us if your circumstances change, and you are unable to run. Please do this at
  your earliest opportunity as we may be able to offer your place to another potential runner (if
  you notify us before the London Landmarks Half Marathon deadline).
- You accept that The Children's Trust accepts no liability in connection for your participation in the event when it comes to any loss or damage of any kind including to you and your belongings. However, this excludes any liability for death or personal injury caused by our negligence or any other liability that cannot be excluded by law.

You understand that any photos, quotes or video footage taken of you during the event may
be used on social media, future marketing, and publicity material and other mediums that may
